How to help him overcome impulsivity/ limited understanding o	f cause and effect as it relates to safety and repetitive behaviors.
Improve his social skills and peer play.	

After review of information provided and discussion of the case, the following recommendations are provided:

Explore behavioral strategies to improve compliance and help him be more available to learn with his peers.

- Meet him where he is and then challenge him on one skill that would be just above his level
- Has a functional behavioral assessment (FBA) been completed? What are the antecedents to his behavior?
- Work on negations with him during language therapy (i.e. "Do not run"...what does that mean? "You should not touch that.")
- What does he like to play with and start there with teaching play with one other peer within a structured session.
- Keeping developmentally appropriate toys and activities in mind that are equivalent with his developmental level
- Good visual schedule within his sessions as well as for his school day
- Choice board, he can choose an activity with the choice board
- "STOP" sign on the door paired with social story to help if he is eloping and running out of class
- Is he working on the picky eating at school? Is he hungry? Potentially causing some behaviors.
- Does he have a reaction when he eats gluten or dairy? What type of reaction?
- Did stopping the foods cause any changes with behavior?
- Co-treating between learning specialist and the SLP, potentially a social language group.
- Are there any community activities of interest to him that he could get involved with?

- Promote play and social skills by meeting him where he is. What is his preferred play and what is one challenge you could add such as slightly changing who he plays with, where, when, or how.
- Ask paraprofessionals if they could take some data about his behavior which could benefit a functional behavior assessment or other behavior plan decision makers.
- Consider the use of visual supports or video models to support his adaptive skills such as toileting and washing hands to encourage more appropriate bathroom behavior. This might include incorporating water play or other sensory stimulation at other points throughout the day.
